

MOTENG NA, LLC –SECTION 18 FORM – REQUIRED

MOTENG NA, LLC CAN ONLY SHIP CERTAIN KNIVES AND FEDERALLY REGULATED PROEDUCTS IN COMPLIANCE WITH FEDERAL STATUTES. YOU MUST MEET THE CRITERIA BELOW. READ THIS CAREFULLY.

Federal law prohibits shipment of automatic knives across state lines, with the following exceptions:

- (1) to supply or procurement officers of the National Guard, the Air National guard, or militia of a state, territory or the District of Columbia ordering, procuring, or purchasing such knives in the connection with the activities of such organization;
- (2) to civilian or Armed Forces supply or procurement officers and employees of the Federal Government ordering, procuring, or purchasing such knives in connection with the activities of the Federal Government;
- (3) to supply or procurement officers or employees of the municipal government of the District of Columbia or the government of any State or Territory;
- (4) to manufacturers of such knives or bona fide dealers therein in connection with any shipment made pursuant of an order from any person designated in paragraphs (1), (2), and (3).

Moteng NA, LLC will NOT sell automatic knives to any individual outside the State of Arizona without the above conditions being met. We must have proof of your status that conforms to the above conditions BEFORE we can send such knives out of state.

1. We need a request made on your letterhead that includes this statement: “I, _____, am a bona fide reseller/dealer and understand the applicable state and federal laws. I understand that the product becomes mine at the point of sale in Arizona. I will comply with all applicable laws and indemnify Moteng NA, LLC for any and all financial ramifications associated with this transaction or my resale of these goods. No sales will be made to the general public and only to individuals and entities described in 18 USC 1716(G)(2)(1-4) and 15 USC 1244(2-4) as well as any state laws that apply to me. My business agrees to pay all attorneys fees and costs of Moteng NA, LLC in the event of any disputes with third parties or with my business.”
2. A photo ID attached to the letter.
3. This Section 18 Form, signed as an acknowledgement of the notices contained herein.

After verification of these facts, your knives will be sent.

Legal status of products: It is the responsibility of the buyer, not the seller, to ascertain, and obey, all applicable local, state, federal and international laws in regard to the procession, and use, of any item purchased from Moteng NA, LLC. All equipment is sold subject to public law 90-351, title 111, U.S.D., Section 2511, and any local, state or federal ordinances. Consult your local and state laws before ordering if you are in doubt. Absolutely no sales to minors. By placing an order, the buyer represents that the products ordered will be used in a lawful manner and that he/she is of legal age. Moteng NA, LLC will not be held liable for the misuse of any product purchased from us or any of our distributors & dealers.
